



DALE HALL COMMUNITY PRIMARY SCHOOL ABUSE, THREATS AND VIOLENCE TOWARDS SCHOOL STAFF

**This policy should be carried out in the context of and in conjunction with
Dale Hall CP School's Safeguarding Policy.**

1. Introduction

On the recommendation of Suffolk County Council Local Authority, this Governing Body has adopted the guidance on Banning Parents and Other Visitors from School Premises from the Dealing with Abuse, Threats and Violence towards School Staff, 2002-2003 Guidance for Schools.

This policy was readopted by the Personnel Committee at its meeting on **8 March 2022**.

2. Delegation

The Governing Body has delegated the day-to-day operation of this policy to the Headteacher.

3. Procedures

3.1 Section 206 of the Education Act 2002 makes it a criminal offence punishable with a fine for a person to trespass on school premises and cause a nuisance or disturbance.

3.2 Parents and some other visitors have implied permission to be on school premises at certain times and for certain purposes and they will not therefore be trespassers unless the implied permission is withdrawn.

3.3 If a parent or other person behaves unreasonably on school premises a letter will be sent to them withdrawing the implied permission for them to be there. The initial letter will be sent by the Headteacher unless he or she has been personally involved in an incident and would prefer the letter to be sent by the Area Education Manager on behalf of the school.

3.4 If a person who has been banned subsequently trespasses and causes a nuisance or disturbance the matter will be referred to the County Council's Head of Legal Services who will write a warning letter.

3.5 Further breaches may lead to prosecution of the person concerned by either the Police or the Head of Legal Services.

3.6 Full records will be kept of each incident, including details of any person(s) who witnessed the behaviour of the trespasser(s) since evidence will need to be provided to the Court.

3.7 Anyone who is dissatisfied with the ban and wishes to object to it will be referred to the school's General Complaints Procedure Policy. This allows for an independent investigation to be carried out by the Area Education Manager on behalf of the Chair of Governors. If the complainant remains dissatisfied after the investigation, there is recourse to the Governors' Hearings Committee.

4. Review

This policy will be reviewed biennially and at other times as necessary.
